If/when he moves into the management role, a new course designer will be located. Trena Kerr suggested that KHJA focus on hiring local people to run the show to keep costs in check.

Leea Bridgeman went over seeding committees to "test" people's engagement before they run for the KHJA Board. Leea also explained how to complete the committee paperwork that was emailed to the Board.

Jennifer Kraemer went over sponsorship information and the creation of a whole-organization ask sheet, including the Fall Classic, grant sponsorships, etc. Jennifer also went over the possibility of expanding KHJA social media and highlighting Board members on Instagram.

President Ashley Watts covered conflict of interest forms and Board Member Requirement documents. Ashley will email these documents to be signed and returned.

Elaine Schott introduced the idea of an Emergency Preparedness Clinic put on by SafetyTec. This event would go over how to handle human emergencies at an equine event. Elaine Schott proposed that KHJA pay Safety Tec \$200 for the afternoon, Maria Kneipp seconded. The event will be held on March 21 at 1 p.m. and will run about 90 minutes. Toasties food truck will be available.
